TREASURER KOSKI Ongoing situation regarding Pat and Amy Dinkins and their PRE and Veterans Exemption on their taxes and they are here in the audience, I would like for Mr. Ulrich to give us a report on the status of this situation and I would also like to know why the mistakes made on this property were blamed on myself, where in my statutory or daily duties does it state that I am responsible for the PRE paperwork or Veterans' Exemption paperwork or for that matter anything to do with changes to the tax roll or the BOR or the Assessors responsibilities. So, during your Assessor's Report I would like an answer to my question please.

- **h. PLANNING COMMISSION** Public Hearing was held on Zoning Map change and it is now in the hands of Marquette County. We are still waiting to hear back from Attorney on Marihuana Ordinance. It was noted that we had received a response just this afternoon and Mr. Oakley asked that the email be forwarded to him.
- i. **ZONING ADMINISTRATOR** Nothing other than the same Zoning issues the Planning Commission just referred to.
- j. ORDINANCE ENFORCEMENT Nothing at this time
- k. SUPERVISOR/ASSESSOR Safety Meetings with DPW every month, two meetings with TIFA, as Assessor, there were two BOR meetings since the last board meeting. As far as the Dinkins are concerned I have explained to them the need for the additional paperwork for a PRE. The Treasurer then asked, but didn't you say that the lack of this paperwork was my fault? The Assessor stated, "No." The Treasurer then asked, if I told you that they still had the voicemail on their phone that you left that states that would you then agree or disagree? The Assessor then stated he would have to listen to the message to recall what he said. He then said that Mr. Dinkins came in to the office and put in an affidavit. There was then discussion about who filled out the affidavit, and Mrs. Dinkins asked if they shouldn't be notified that there should be all parcel numbers affected, give them some guidance? Mr. Dinkins stated that there had never been a problem until this Assessor took over. There was additional discussion. Mrs. Dinkins asked what was the difference between the PRE and the Veterans Exemption? The Assessor said that he looked at the previous records and could not see a PRE ever being granted, the Treasurer then stated that in her computer files both properties had 100% PRE for the 2017 tax year. Mr. Ulrich then asked would the two BOR members present like to say anything about this? Mrs. Radcliffe stated that as long as the two properties touch or are contiguous then they should both be granted the PRE, regardless if there is a section line between them. There was discussion from Mr. Johnson about how he handled this situation previously and the frequent problems with BS&A software. It should be noted that the Assessor never really answered the Treasurer's question regarding what her duties were, nor did he answer Mrs. Dinkins' question regarding the difference between a PRE and a Veteran's Exemption.
