7. REPORTS:

- a. TRUSTEE FELDHUSEN- Nice to see the campground sign fixed
- **b. TRUSTEE STANKUS-** Meeting with UPPCO, tour of building for an energy efficiency study. They will send us a report. Also noted that the roof on the water filtration plant building is in poor condition and we should get that fixed before this coming winter. I also toured all the other buildings.
- **c. CLERK BRANCHEAU** I would appreciate it if we could receive the agenda with all of the attachments prior to the meeting day.
- **d. TREASURER KOSKI** Nothing at this time.
- e. **DPW** Nothing at this time
- **f. IOHT** There is a sign going up right by the trail entryway, the bike stop and bench will be up by September and they are ready to write a check for the old bank building when we need it.
- **g. FIRE/AMBULANCE** Nothing at this time
- **h. PLANNING COMMISSION** First the County gave their approval for the rezoning of the North Bank Lane properties, which now should be before the township board. Second the Rec Committee has made a recommendation to the

PC to remove the Witch Lake Playground, the PC has unanimously agreed and have put that to the Board for a decision. The deed needs to be reviewed to be certain the removal of the playground will not be in violation. The Planning Commission will be holding a public hearing at their next meeting regarding the Medical Marihuana Zoning. Master Plan and Rec Plan are under review. Mr. Brennan agreed to get a copy of the deed for review.

- **j. ORDINANCE ENFORCEMENT** 3 new complaints filed, 1 is resolved, 1 is unfounded at this time, the other originated as a junk vehicle complaint, but upon inspection it appears that the building may be unsafe. It looks as though we will need to have a dangerous buildings hearing officer if it comes to that, so we need to look into that. Will contact the people again about getting that old building removed down by Fence River Road.
- **k. SUPERVISOR/ASSESSOR** Congratulate this year's graduates. Safety Meetings with DPW every month, attended MTA conference and the MCTA meeting. Assessment Roll has been rolled over the 2018 tax year.

- **a. Old Bank Building Grant** Revised documents to be submitted to DNR, get them approved and hopefully go out for bids soon.
- **b.** Lindholm There is an amended Court Order pending that the Board needs to approve regarding their Chief Lake Property. Motion by Supervisor Ulrich, seconded by Treasurer Koski, all in favor, motion carried.
- c. Roads This has been discussed previously, to do gravel work on Walstroms Road the cost is about \$16,586.79 which works out to be approximately half of the road this year and then the other half of the road will be discussed next year. They can only do half this year because of the cost and time involved on trucking the gravel. Treasurer Koski went on to state that as many of you are aware, we had discussed getting gravel form the 40 acres we own on the other side of M 95 but because of a complaint by one citizen that was put on hold.
