PLANNING COMMISSION The public hearing for the new rec plan will be held on February 12, 2018 @ 7:00pm, election of members, and coming to the board for approval to apply for a grant to see if we can get new playground equipment for no more than \$35,000. Mr. Oakley objected to using the current quote that Mr. Brennan had because it stated \$37,000. Mr. Brennan stated that this is the quote that we received that includes installation, the equipment costs are actually far less, we may be able to trim some costs but it has to be looked at by the engineers and they have to start with something and there are other places where we can try to get funds. This will be discussed at budget time.

- **j. ORDINANCE ENFORCEMENT** Requested trial date for Lindholm's, they have scheduled another pre-trial conference
- **k. SUPERVISOR/ASSESSOR** Safety Meetings with DPW every month, several TIFA Meetings, several meetings with Roger Crimmins and DEQ on the dam. MTA Meeting, and Well head meeting. Finished construction inspections, did drive around the township, UPPCO meeting, and Central Dispatch Meeting.

### 8. UNFINISHED BUSINESS:

- **a.** Sewer Grant–Still signing paperwork, changes were made in the funds.
- **b. Old Bank Building Grant** Recreation passport grants are being worked on to find additional funds for this building project. UPEA is working on that.
- **c. Medical Marijuana** We have received feedback from Fahey/Schultz that should be taken into consideration. The best thing to do is have a PC/Board combined meeting to discuss all of this. Scheduled for February 27 @ 12 noon.
- **d. 5 Year Recreation Plan** The public hearing is set in February as previously stated.
- e. Township Road Paving— When taxes are received this year we should have just shy of \$150,000 in the coffers, so no serious work can be done, but we had previously approved Walstroms Road to be redone in gravel, so that needs to be checked on as to why it wasn't done. Hawks Drive could be addressed again after the dam gate issue is settled.
- f. Campground Business Kim Isaacson has submitted a letter to the board requesting to do a Facebook page for the campground and also requested a golf cart for campground maintenance (tabled until budget). Motion by Supervisor Ulrich to allow Kim to do the Facebook page, seconded by Trustee Feldhusen, after discussion, motion amended by Supervisor Ulrich, seconded by Trustee Stankus to put tight security on the page to not allow random posting, all in favor, motion carried. The second thing is the ad with Michigan Trails magazine for 1/8 page for \$395.00 this was discussed last year and we wanted to wait for this year.
