- **d.** Dave Grace Sheriff has been involved with the gun issue for the issues on 601 with Ison and Anderson. Letter has gone out for camper that is still there and we have given 10 days to remove, (August 5^{th}), if not citation will be issued. If this does not resolve the issues over there, it would be prudent to involve Mr. Koch in helping us to find a resolution.
- e. NMPSA Renew membership, \$15.00 each X 5 members = \$75.00 total
- f. MCRC Wants to use our gravel pit on River Road for road repairs for Walstroms Road etc. It would save on expenses for these road repairs. Mr. Perry was recognized to speak. He stated that the land in question is deed restricted as it was donated to the Township for recreation purposes, there was never supposed to be a gravel pit there. He has a copy of the deed at home. Trustee Stankus suggested that we contact the county to get a copy of the deed. He suggested that Mr. Koch take care of it. Mr. Brennan stated that this had been researched before by Dan Mitchell and the Planning Commission, that it was determined that it could be used for gravel if we so chose.
- **g.** Volunteer Emergency Coordinator Supervisor Ulrich has asked Mr. Ted DeWitt to be the Emergency Coordinator to be the "Right Hand Man" for Supervisor Ulrich who is the Emergency Management Director. Rec Committee Jim Brennan presented a brochure for the township that they would like to distribute to welcome centers around the area, there was some discussion, motion by Clerk Brancheau, seconded by Treasurer Koski to approve as is, all in favor, motion carried. Mr. Brennan also spoke about the TIFA, and contacting MDOT for campground signs. We could also speak to the IOHT about

getting possible help from the DNR for signage. There are 5 picnic tables left to do and gave an update on the Dam issue.
