# TOWNSHIP OF REPUBLIC

# MARQUETTE COUNTY, MICHIGAN

WHEREAS, The Township of Republic, Marquette County, Michigan under the authority of Public Act 94 of 2008, has determined that it is necessary for the best interest of the public to promote water resource improvement and access to inland lakes, in a water improvement resource district, and:

WHEREAS, The Township of Republic, did establish a Water Resources Improvement Tax Increment Finance Authority, Development Plan, and a Tax Increment Financing Plan, and

WHEREAS, The Township of Republic water resources include the Michigamme River Flowage, recreation facilities, boat access, campgrounds and public facilities.

WHEREAS, The Township of Republic water resources depend on the continued maintenance of a flowage spillway or dam, and

WHEREAS, The Township of Republic, has determined that the original district boundaries as adopted will not provide sufficient capital to fund the proposed infrastructure improvements within the district.

WHEREAS, under the authority of Public Act 94 of 2008, the Township of Republic resolves that the boundary of the implemented Development area to be expanded to include all of the parcels of land contiguous to the shores of the Michigamme River, encompassing the following described property lying within Republic Township, Marquette County, Michigan:

# Township 46 North, Range 29 West

Entire Sections 6, 7 and 18,

### Section 5,

The South Half of the Southwest quarter (S1/2, SW1/4) and the West half of the Northwest quarter (W1/2, NW1/4),

#### Section 8.

All that part of Section 8, lying West a line described as follows: Commencing at the South quarter corner; then S89°50'53"W, along the South Section Line 1149.70 feet to the Westerly line of the Republic Wetland Preserve and Point of Beginning; then

N02°50'13"W 196.57 feet to a point on the North line of the Southwest quarter, being 151.16 feet East of the Southwest corner of Government Lot 4; then continuing N14°50'13"W 657.67 feet to the centerline of County Road LF; then Northerly along said centerline 750.0 feet, more or less to the North line of Government lot 4; then Northerly along the West line of the Moose Country Snowmobiler's parcel to the North line of Section 8 and the Point of Ending.

Section 17,

All of Section 17 EXCEPT tax parcel 52-12-017-003-00.

Section 19,

Government lots 1, 5, 6 and 7; that part of Government lots 2, 3 and 4 lying East of County Road LLL EXCEPT tax parcel 52-12-019-033-30; the Northwest quarter of the Northeast quarter (NW1/4, NE1/4); and the North half of the Northwest quarter (N1/2, NW1/4).

Section 20,

The North Half of Section 20 (including Government lot 1);, and the West half of the Southwest quarter of the Southwest quarter (W1/2, SW1/4).

Section 30,

Government lot 1 EXCEPT tax parcels 52-12-030-008-00, 52-12-030-010-00, 52-12-030-001-00, 52-12-030-011-00; that part of the Government lot 2 lying East of County Road LEA and East of Country Road LLL EXCEPT tax parcel 52-12-030-018-00; and that part of Government lot 3 lying East of County Road LEA and North of County Road LI EXCEPT tax parcel 52-12-030-023-00.

Entire sections 1, 2 and 12

Section 11,

The Northeast quarter of the Northeast quarter (NE1/4, NE1/4).

Section 13.

The East half (E1/2), The North half of the Northwest quarter (N1/2, NW1/4); the Southeast quarter of the Northwest quarter (SE1/4, NW1/4); and the Northeast quarter of the Southwest quarter (NE1/4, SW1/4).

Section 24,

The Northeast quarter of the Northeast quarter (NE1/4, NE1/4).
