- **4. Approval of Agenda,** as presented, **Motion** by Mr. Kraft, 2<sup>nd</sup> by Mr. Sandblom, Motion passed by voice vote.
- 5. Approval of Minutes
  - **A. PC Minutes (Draft) July 11, 2016,** as presented, **Motion** by Mr. Kraft, 2<sup>nd</sup> by Mr. Sandblom, Motion passed by voice vote.
  - **B. Rec Minutes June 1, 2016,** as presented, **Motion** by Mr. Feldhusen, 2<sup>nd</sup> by Mr. Kraft, Motion passed by voice vote.
  - C. Rec Minutes July 6, 2016.....below.
  - **D. Rec Minutes August 3, 2016.** Both July 6 and Aug 3 Rec minutes were returned to Mr. Brennan because there was no quorum at the Aug 3<sup>rd</sup> Rec Comm meeting. The PC was unwilling to approve a meeting in violation of the Open Meeting Act. The Chair instructed Mr. Brennan to provide a signed written list of Rec. Comm. members to the PC by the next PC meeting.
- **6. Public Comment:** Recognized were; Mr. Brennan, Mr. Mitchell, Ms. Helmila, and Ms. Maze. An 8 minute open discussion took place.
- 7. Reports.
  - A. Zoning Administrator's Report. Mr. Mitchell gave a brief non-specific report.
    - 1. CLWYC Conditional Use Permit. Later, Mr. Mitchell brought forth a request from the CLWYC for an extension of their Conditional Use Permit. Mr. Mitchell gave a brief history and reason for approving the request. A brief discussion followed. Then, Mr. Sandblom made the flowing Motion: "I move that the Republic Planning Commission approve a two (2) year extension to the existing CUP (9.22.14) AND EXTENSION (8/27/15). All conditions to remain in effect until September 1, 2018. Further that article 8 of the 2015 extension is extended until September 1, 2018 to enable the CLWYC to continue their funding efforts anf to make the extension congruous for the upcoming examinations by future Planning Commissions. Monday, August 08, 2016." Motion was 2<sup>nd</sup> by Ms. Maze; Roll call vote: Mr. Richter, Yes, Mr. Kraft, Yes, Mr. Sandblom, Yes, Mr. Feldhusen, Yes, Ms. Maze, Yes, Mr. Nannestad, Yes. Motion passed. (For the record, a letter to CLWYC is attached).

- B. Fire/EMS/TIFA....Ms. Maze gave a brief report on her efforts to persuade the township board to request a millage at the next election for the fire department. Ms. Maze asked to have a copy of her e-mail forwarded to each PC member. Chair, said he would accomplish that request. We thank Ms. Maze for her efforts.
- C. Recreation Committee....Mr. Brennan: Mr. Spear was present and gave the 6 minute report. Mr. Spear reported on progress as well as unexpected delays.

A budget will be prepared to cover the extensive expenses expected for the completion of the Supervisor ordered procedure. In addition, it was recommended to submit a budget for updating the Master Plan required by the Enabling Act.
